Introduction

The Pradhan Mantri KIsan SAmman Nidhi scheme, popularly known as PM KISAN scheme was launched by the government of India in 2018 to provide income support to farming families. Under this scheme, each farmer's family is entitled to receive ₹ 6000 per annum. This amount is paid in 3 instalments of ₹ 2000 to all registered farmers through direct benefit transfers (DBT) to their bank account. All accounts are vetted through various steps for valid Aadhar cards and bank accounts before the states check their eligibility to receive the amount.

About the Report

The objective of this report is to provide a snapshot of the PM KISAN scheme's implementation in the state of Telangana. Many farmers are unable to receive the benefits owing to delays in approval, data errors, Aadhar based rejections and various transaction failures beyond their locus of control.

This report examines PM KISAN's implementation in the 32 districts in Telangana. Data available in the public domain has been used for this report. We used the data available as on 26-08-2021 for the 8 installments from December, 2018 to July, 2021. Through this report, we have attempted to capture the successes in implementation of the scheme as well as some of the barriers to its effective enactment. We hope our observations and subsequent recommendations contribute towards improving the programme and providing much needed relief for farmers in the State.

Key Statistics


3,840,670 farmers have been registered so far in PM KISAN since the inception of the scheme and are eligible to receive 28,321,570 instalments amounting to ₹ 5664 crores. Considering the nature of the cash transfers, validation errors and transaction failures have been the focus of our analysis. For the sake of simplicity, we have collapsed the various reasons for rejection and categorized them based on authorities responsible for clearing the roadblocks. Some key observations are summarized below:

In nutshell, 89% of the farmers in the beneficiary list have received all installments. Less than 2% have not received any installments and 9% farmers received part installments.

- 1. 3,840,670 Registered farmers and eligible for a total of 28,321,570 instalments, i.e ₹ 5,664 Cr
- 2. 3,773,259 -: Farmers benefited by receiving 26,555,628 (93.7%) installments, i.e ₹ 5,311.12 Cr
 - a. 3,413,060 (88.9%) farmers received all installments due to them
 - b. 360,199 (9.3%) farmers received at least one installment and yet to receive ₹ 274.87 Cr collectively #(on an average missed 3.8 installments)
- 3. 67,411(1.75%) -: Farmers didn't receive any benefits, on an average these farmers missed 5.8% instalments amounting to ₹78.31 Cr in total.

While more than 90% of the due amount was transferred, it is evident that a small but significant amount is still due. 11% of the farmers have not received their due amount. Total amount of missed instalments in Telangana account for 353 crores INR thus far. Among farmers with missing instalments, 3 major issues – Bank Rejections, payments stopped by the state, and Aadhar verifications; account for 70% of the pending instalments.

District wise Beneficiaries:



The district level picture shows some variations. However, except for Medchal district, in all other districts more than 80% of farmers have received all due instalments- a creditable performance. Nagarkurnool, Nalgonda, Yadadri and Narayanpet are the other 4 districts where scheme implementation is less positive.

Registrations Vs Benefitted Farmers:

As mentioned in the earlier section there are about 38.4 lakh farmers registered on PM KISAN MIS and about 37.7 lakh farmers received at least one instalment, that amounts to ₹ 5311 Cr in Telangana so far. Table 2 provides an overview of the number of registered farmers and those who were benefited by receiving at least one instalment along with the proportion of payments still due. More than 6% of the payments have not reached the farmers amounting to Rs.353 crores




While nearly 90% of the farmers received all instalments, the table below shows that a total of more than Rs. 353 crores is still due.

The absolute amount of payments still due shows that Sangareddy, Rangareddy and Nalgonda have more than 20 crore rupees due in each of these districts and would require urgent resolution.

As a proportion of payments due - Medchal data shows that more than 12% of the payments have been missed. Rangareddy also has nearly 10% of payments still due. Sangareddy, Vikarabad, Yadadri, Nalgonda, Mulugu and Narayanpet all have more than 7% of the payments still due.

Exclusions:





This shows that nearly two-thirds of the cases of missing instalments are due to bank related reasons, or Aadhar related. Of them, aadhar related issues (aadhar number not verified) are more important. It is also important to note that while these two issues account for 64% of the payment issues, they add up to a staggering 72% of the missing amount.

Interestingly a significant number of farmers are seen to have missed instalments - as they are ineligible for the benefits (income tax payee etc) – its unusually high in some districts.

When a farmer is considered ineligible, they should have received zero instalments.

However very few farmers have received zero instalments.

Conclusion

Benefits of the PM KISAN were received by the majority of the registered farmers from the state. However, the number of farmers registered itself is an issue, considering the fact that the state sponsored Rythu Bandu have nearly 25 lakh¹ more farmers are getting benefitted than the registered farmers in PM KISAN.

Even if we consider the issues like, Income tax payees, ROFR farmers and only one beneficiary per family being reasons for the gap, 25 lakhs is a huge number. And the eligible farmers from the state are losing money from the central government, so it's high time for the state government to review the scheme implementation in the state and ensure that all the eligible farmers receive the benefits under PM KISAN. We recommend that the state consider campaigns during the PM KISAN registration period and encourage farmers to register themselves to avail benefits. We recommend the agriculture department to seek support of Dept of Panchayat and Rural development, who had considerable experience in the resolution of 'Bank Rejection issues' in MGNREGA.
