


About this report

This report compiles data on Employment Generated in Andhra Pradesh from Apr-Sep 2023 (current year) and compares data for the preceding financial years 2021-22 and 2022-23 for the same time period. The analysis relies on information downloaded from https://nrega.nic.in/ as of 06-10-2023. Our aim is to provide citizens and stakeholders with insights into the present status of MGNREGA implementation in Andhra Pradesh.



April to September

1. Key Statistics

2. Employment at State Level

2.1 Comprehensive Analysis of Employment Metrics and Trends

18.9% increase in persondays generated in FY 2023-24 when compared to the same period in FY 2022-23

Ideally, MGNREGA, as a demand-driven employment program, should align with the workers' demand, evident in the number of Households employed and workdays generated. However, the central government's stringent control over budget allocations and states' varying political will and administrative capacities highlight the significance of employment-related figures as vital indicators of NREGA effectiveness. Evaluating MGNREGA employment performance involves considering metrics such as Number of Households employed, participation of vulnerable Households, average persondays of employment generated and number of Households completing 100 days.

Key trends in MGNREGA employment in AP:

I. Households Worked:

FY 2023-24 showcases a significant recovery in the number of households worked, marking a positive turn around to 122.9 lakhs. This represents a notable increase of approximately 19% compared to the preceding fiscal year (FY 2022-23) when there was a significant drop to 103.3 lakhs. The encouraging trend aligns with the national story, where the total households worked for India also saw a rebound from 1144.16 lakhs in Apr-Sep 22-23 to 1326.45 lakhs in Apr-Sep 23-24, reflecting a remarkable increase of 15.9%

2. Persondays Generated:

FY 2023-24 demonstrates a positive trajectory in persondays generated, reaching 2035 lakhs. This indicates a recovery of around 18.9% compared to the downturn observed in FY 2022-23 (1711 lakhs). The encouraging revival aligns with the national trend, where persondays generated for India also increased from 16572.17 lakhs in Apr-Sep 22-23 to 18802.55 lakhs in Apr-Sep 23-24, reflecting a substantial rise of 13.5%.




Figure 1: Employment Trends (Apr-Sep Yearly Comparison) at State Level.

2.2 Employment at District Level

In the fiscal year 2023-24, Andhra Pradesh demonstrated an impressive overall increase of 18.9% in total persondays generated through NREGA in comparison with 2022-23. This positive trend signifies a substantial boost in NREGA engagement across the state. Notably, every district experienced growth in persondays, with several districts registering significant increases. ASR, NTR, and Nellore stood out with remarkable upswings of 34.3%, 36%, and 37.8%, respectively. In contrast, Sri Satya Sai (4.3%), Prakasam (5.2%), and Eluru (6.6%) showed relatively modest increases. The positive trajectory observed in each district collectively contributes to the state's overall progress in NREGA participation. This holistic growth underscores the efficacy of rural employment initiatives in Andhra Pradesh during the specified fiscal year.




Figure 2: District-wise persondays comparison of Apr-Sep 2023-24 and Apr-Sep 2022-23

2.3 Employment Trend in Apr-Sep 2023-24 for Different Categories of Workers

In the period from April to September 2023-24, Andhra Pradesh witnessed substantial growth in NREGA engagement across different groups of workers. Notably, the Scheduled Caste (SC) category showed a significant increase of 15.8%, with persondays reaching 471.13 lakhs co mpared to 407.01 lakhs in the same period of the previous fiscal year. The Scheduled Tribe (ST) group demonstrated remarkable growth, recording a notable 31.2% increase in persondays, escalating from 159.45 lakhs to 209.24 lakhs. Workers falling into

the 'Others' category also experienced a noteworthy uptick, with persondays rising from 1144.52 lakhs to 1354.71 lakhs, reflecting an 18.4% increase. Collectively, the overall persondays surged from 1710.98 lakhs to 2035.08 lakhs, marking an impressive 18.9% growth. These key observations underscore the inclusive impact of NREGA in providing employment opportunities across diverse sections of the population in Andhra Pradesh.

Disclaimer: This report refrains from discussing the current status of workers who faced deletions in the fiscal year 2022-23, during which a significant number of MGNREGA worker deletions occurred. The Office of Rural Development, Government of Andhra Pradesh, is actively involved in addressing and resolving these issues on the ground. We intend to provide an update on the status of these workers in our annual tracker, set to be released in April 2024. 3. Conclusion

The analysis of MGNREGA employment in Andhra Pradesh for April to September 2023 reveals promising trends. Comparing data from preceding years, the state demonstrates a noteworthy 18.9% increase in persondays, reflecting positive strides in the program's impact. The resurgence in households worked aligns with national efforts to revitalize MGNREGA. District-wise evaluations highlight overall growth, with districts like ASR, NTR, and Nellore leading. Modest increases in Sri Satya Sai, Prakasam, and Eluru indicate areas for improvement. Employment trends across different categories show inclusive growth, particularly for Scheduled Castes, Scheduled Tribes, and others.

In conclusion, the findings suggest positive momentum in MGNREGA in Andhra Pradesh. The increase in employment opportunities, especially for vulnerable groups, underscores the program's success in fostering inclusive rural development. Addressing district-wise variations remains crucial for optimizing the program's impact statewide.
